Fresh Summerfruit Overview


Pages 186-187 profile total summerfruit production and trade. They combine information on apricots, nectarines/peaches and plums. The following pages profile each summerfruit category in more detail. For the year ending June 2018:

- 153,148 t was produced.
- The value of production was \$397.8 m while the wholesale value of the fresh supply was \$391.7 m.
- 50% of Australian households purchased a summerfruit, buying an average of 597 g per shopping trip.
- The supply per capita of summerfruit was 4.3 kg, based on the volume supplied.

EXPORTS – 2018/19 - SUMMARY

- Australian summerfruit industry exported 23,013 tonnes of nectarines, peaches, plums and apricots
- Worth \$88.95 million,
- Achieving a unit value of A\$3.87.

This was a new record result for volume, value and unit value.

Countries:

- China was the lead market for nectarines, peaches and plums
- Saudi Arabia was the lead market for apricots.

Exports by Volume:

- Nectarines 40%
- Peaches 28%,
- Plums 30%
- Apricots 2% –

This was the same as last year.

By State:


- Victoria was the largest export state followed by New South Wales. These states combined accounted for 91% of the exported volume.
- Western Australia dipped 41% to account for 3% of national exports.

Exports have


- increased by an average 6% per year over 10% per year
- increased 29% year-on-year to 2017/18 driven by China demand.

Over 10 years summerfruit imports by key Asian markets from all sources have increased from 101 to 162 thousand tonnes. China is the largest importer of summerfruit in Asia.


Australian Summerfruit Exports since 1996
